



**AFFIDAVIT OF RESIDENCE**

This form shall be completed for students living in The Peach County School District, but living with the Parent/Legal Guardian in the in the home of another family. This form shall be completed by both the Parent/or Legal Guardian AND the homeowner. This form shall be renewed yearly prior to the start of the next school year. The school shall require the following prior to acceptance:

- Both the Parent/Legal Guardian and the Home Owner/Lease Holder shall appear before the school Principal (together) for notary of said affidavit of residency. In addition, the Home Owner/Lease Holder shall provide proof of their residency for said address.
- Parent/Legal Guardian shall provide proof of utility cut off from prior address. If no utility cut off can be provided, then Parent/Legal Guardian shall obtain previous address verification information from the post office.
- If the residence is considered public housing, then form HUD-50059 shall be provided to the school. Form shall list all tenants of the address including children.

The school system’s Superintendent, or his/her designee, may verify the facts contained in this affidavit and conduct an audit on a case-by-case basis after the child has been enrolled in the county public school system. The audit may also include a personal visit by district personnel at the residence provided in this affidavit to verify the facts sworn to this affidavit. If the Superintendent discovers fraud or misrepresentation, the child shall be withdrawn from school.

I attest that this request to attend a Peach County School is not primarily related to attendance at a particular school in Peach County, nor is this affidavit being completed for the purpose of participating in athletics at a particular school, taking advantage of special services or programs offered at a particular school, or for any other similar purpose.

I further attest that the student named above is not now under a long-term suspension or expulsion from his/her most recent school nor is currently subject to a recommendation for long-term suspension or expulsion from his/her most recent school

**NOTICE OF PENALTIES AND LIABILITY:**

I understand that:

1. If I falsify information or defraud the school system on this affidavit, I will be obligated to pay for the costs incurred by the local school system for the period during which the ineligible student is enrolled, and shall remunerate the local school system as set forth in O.C.G.A. § 20-2-133 (a). \_\_\_\_\_ (initial)
2. If the costs incurred by the local school system are collected by an attorney, I will be obligated to pay for all expenses and attorney’s fees incurred by the Board of Education in the collection of same. \_\_\_\_\_ (initial)
3. I may be prosecuted, held criminally liable, and imprisoned for not less than one nor more than ten years if I am found guilty of forgery in the first degree, pursuant to O.C.G.A. § 16-9-1. \_\_\_\_\_ (initial)
4. I may be prosecuted, held criminally liable, and imprisoned for not less than one nor more than five years if I am found guilty of forgery in the second degree, pursuant to O.C.G.A. § 16-9-2. \_\_\_\_\_ (initial)
5. I may be prosecuted, held criminally liable, and punished by a fine of not more than \$1,000.00 or by imprisonment for not more than one nor more than five years, or both, if I am found guilty of making false statements pursuant to O.C.G.A. § 16-10-20. (initial)

6. I may be prosecuted, held criminally liable, and punished by a fine of not more than \$1,000.00 or by imprisonment for not less than one more than five years, or both, if I am found guilty of false swearing pursuant to O.C.G.A. § 16-10-71. \_\_\_\_\_ (initial)
7. By initialing on the lines provided next to each of the items listed above, I affirm that I have read and understand each of these provisions.

I solemnly affirm under the penalties listed above that the contents of this affidavit are true to the best of my knowledge, information, and belief.

**Parent/Legal Guardian:**

I clearly understand that within 30 calendar days (\_\_\_\_/\_\_\_\_/\_\_\_\_) I must provide proof of residence at the above address or my child(ren) will be withdrawn. Examples of acceptable residence verification are as follows: bank statement (local bank), utility bill in your name (current month), mail from official government agency, or official Confirmation of Change of Address from the Post Office. I understand that a cell phone bill or other generic mail is not acceptable.
