You are invited to submit a formal proposal (bid) for ClearTouch Interactive Flat Panel Displays for the Peach County School District in accordance with the attached General Conditions and Specifications.

Proposals from bidders will be received by Peach County Schools, 1088 Tulip Dr., Fort Valley, Georgia 31030 until 11:00 A.M. local time, on **Wednesday, January 27, 2021**. Proposals must be emailed to the attention of Jacob Gresham at jgresham@peachschools.org.

Emailed proposals will only be deemed accepted for consideration upon delivery of a confirmation email from jgresham@peachschools.org to vendor's email indicating receipt of proposal. If vendor does not receive confirmation of receipt of proposal via email, vendor should consider proposal not to have been delivered.

Peach County reserves the right to postpone bid opening to later the same day beyond original due date/time in event of delay of email services. Once time has been called and the first proposal has been opened, any proposals received thereafter will be rejected. **Proposals must be valid for a minimum period of 90 days after bid opening.** Vendor should specify how long the bid will be valid if > 90 days. Peach County Schools reserves the right to reject any and all bids or to waive any informality in bidding. Once bids are submitted and prices recorded, pricing shall become property of Peach County Schools and shall not be considered proprietary. Pricing will be publicly available and posted for review at one of the district's monthly board meetings.

GENERAL CONDITIONS

The Peach County School System seeks competitive bids for 75" 6000K+ model ClearTouch Interactive Flat Panel Displays as per the specific criteria to follow. The district intends to purchase approximately 80 panels to be installed in the new Peach County High School facility which is currently under construction.

Respondents must use the Proposal Submittal Form below in addition to any other bid submittal documents. By submitting a proposal, vendor is acknowledging and accepting the expectations and specifications laid out in this RFP.

NO QUANTITIES OF PURCHASES ARE GUARANTEED. This RFP is for the purposes of establishing pricing and a purchasing partner for ClearTouch Panels for the remainder of the 2020-2021 fiscal year ending June 30, 2021. For vendor planning purposes, 80 panels are likely to be purchased, but no purchases are guaranteed.

- Vendor must supply all required parts and labor and specify costs to deliver a fully assembled, functional product.
- Vendor will deliver or manage the delivery of ClearTouch Panels and supporting equipment to the school site.
 - District will not accept drop shipments or coordinate the delivery of panels from the manufacturer.
 - Vendor will at the time of delivery move panels into assigned classrooms and ensure they are secured.
- Vendor will be responsible for assembling stands, mounting panels, and delivering panels to specified rooms.
- Vendor will plug in and test each panel in its assigned classroom to ensure panel and associated peripherals work as designed.
- Vendor will dispose of all boxes and shipping materials associated with this purchase at an offsite facility. The district will not provide dumpsters for disposal of any shipping or packaging material generated from this project.

Trade Names "or Equal" Clause

No product substitutions will be allowed.

While zero quantities are guaranteed, the district has plans to purchase a minimum quantity of 80 displays from this RFP over the next several months. Additional units and optional components may be purchased depending on bid results and available budget. NO PURCHASES ARE GUARANTEED IN THIS RFP. The district reserves the right to cancel this bid at any time.

The Peach County School System may accept any bid offered on an all, some, or none basis, within funds available, whichever is in the best interest of the school system.
